## H. LISTING AND ORDER OF AGENDA ITEMS

ITEM 1: **Discussion of the appointment of Barbara Cerny to fill vacant board seat.**After discussion, a motion to appoint Barbara Cerny to fill a vacant board seat was made by Patti Aston and seconded by Noel Spaid. The motion was carried

unanimously.

# ITEM 2: Nomination of Board Officers for the term April, 2012 -March, 2013.

Dennis Ridz, Chair, Kenneth Jenkins, Treasurer; and Bob Shopes, Secretary were unopposed candidates for reelection to their officer seats. Noel Spaid ran in opposition to incumbent Vice Chair Cathy Kenton. Ms. Spaid was elected as Vice Chair.

- ITEM 3: One Paseo Draft Environmental Impact Report Discussion of DEIR included traffic especially the "unmitigatable" sites and from the TPCPC point of view Mango and Portofino; public safety; increased student populations; need to include impacts on "peripheral" areas including the TPCPB area, the impact of surrounding schools (CCA, Cathedral, SD Jewish Academy); size and scale including comments from the community and from Robert Little (Kilroy). The Board will make comments on the DEIR by the deadline.
- ITEM 4: Crown Castle Amato's/Cell Site project 254752 presented by Mark Linman. The Board recommended that Mr Linman return in 2-3 months after investigating other design options for the tower.
- ITEM 5: **Reiger Residence Project 266665 presented by Mark Christopher.** The city corrections have been made. The project was approved with the caveat that all ground water issues have been resolved with Development Services.
