# I. BRIEFING, INFORMATION, QUESTION & ANSWER (Non-Action)

#### A. Dan McAllister – Tax Collector – General Info:

- Mr. McAllister spoke to the Board and is the tax Collector for San Diego County.
- He stated that: 984,000 bills were sent out and \$5.4 Billion was collected this year.
- Nancy Moon asked Mr. McAllister about the parent/child exclusion property tax breaks.
- It was stated that over 50% of property tax payers pay by some form of electronic payment.
- In addition, it was also stated that as of May 2015, San Diego is the 5<sup>th</sup> most expensive housing market.
- Last year there was almost \$30 million in property taxes collected just from Del Mar.

# C. David Akin – Public Utilities Department – San Diego:

- Mr. Akin spoke to the Board and is the Public Utilities Customer Advocate.
- In discussing water, he stated that there are 28 water distribution reservoirs and 9 lakes in San Diego County.
- He stated that on utility bills: 1 HCF (Hundred Cubic Feet) = 748 Gallons.
- During times of drought, it is important to check for water leaks. Anyone can do this by simply turning everything off in their home and going out to their water meter and checking to see if it has stopped or still turning. If the meter gauge is still turning, then water is running somewhere past the meter and that may be a sign of a leak.
- It was discussed that 99.6% of meter reads are accurate.
- Current irrigation restrictions call for only 2 days of watering per week with only 5 minutes of watering on those days.
- As of July 1<sup>st</sup> there is more funding for incentives/rebates for turf conversion.

- Supervisor Dave Roberts visited the Olivenhain Water Reclamation Center.
- The Torrey Pines Community is part of the City of San Diego's Water Department.
- Noel Spaid asked Adam Kaye about the West Nile Virus that has affected birds in the County. Adam Kaye reported that there have been more cases this year than last.
- There is concern about the Los Penasquitos Lagoon mouth being kept open so the mosquito population doesn't get out of control with the standing lagoon water.

# C. Senator Block – Sarah Fields
