- Proposed Motion on Fast Response Squad: The Torrey Pines Community Planning Board requests that a two person Emergency/Fire Fast Response Squad be located West of I-5 during construction phases of Kilroy's One Paseo project and remain in place until the City Traffic Engineer and the City of San Diego Fire Chief can certify that the Synchronized Traffic Control System meets the City of San Diego's seven (7) minute emergency response time to fire/emergency calls (911) from Fire Station 24 located in Carmel Valley to Torrey Pines area west Del Mar Heights Road, and request that synchronized light system be installed and working before One Paseo construction commences.
