- I. BRIEFING, INFORMATION, QUESTION & ANSWER (Non-Action)
 - A. Signs On Carmel Valley Road Dan Jensvold; State Park Signs in walkway/Carmel Valley Road:
 - This issue and discussion was moved to January's agenda.

B. CDC Issue/Proposals – Joe La Cava and Cathy Kenton; due date for response 12/16/15 LDC update: Board has no authority, but can render opinion:

- Cathy Kenton spoke about her involvement with CPC (Community Planners Committee), and introduced Joe La Cava (Chair of CPC) to the Board.
- Mr. La Cava spoke about land development code (zoning) and six of the 38 proposed updates that are scheduled to be presented to the Planning Commission in late January 2016.

C. Neighborhood Priorities Project – Dee Rich:

- Dee discussed with the Board some suggestions for updated priorities within our community. She was appointed to collect data and prepare a response.
- After review and discussion, the Board ranked the priorities based on importance:
 - 1. Lagoon Maintenance Schedule for community health and safety, the Los Penasquitos Lagoon needs a schedule for funding and regular maintenance.
 - 2. Public Safety short-term solution to fire/emergency response, Fast Response Squad and long-term placement of a "Brush Fire Truck" west of I-5. In addition, the safety issue of children walking to school along the busy Del Mar Heights Rd. with no safety barrier between them and cars going by.
 - 3. Park Construction the community is short on park space and the park fund is missing the approximate \$2m that is supposed to be set aside for park space.
 - 4. Public Transit there is no public transit in place within our community.
 - 5. Sound Abatement measures to improve sound abatement from freeway noise.

ACTION ITEMS – Action Items this month

A. City Climate Change Plan – Action/Commentary by Board:

- Noel Spaid agreed to send a draft letter response that supports mass transit, to the Board for review.
- Troy Van Horst motioned to approve this idea, seconded by Patti Ashton, and unanimously approved by the Board.

B. Sandag's Transportation Plan – Eduardo Savigliano, how do we continue our opposition with suggestions invited from all:

- Eduardo Savigliano discussed Sandag's plans to widen I-5.
- After much discussion, it seems that Sandag doesn't have a solution for the growing population and transit except for widening the current freeways.
- It was discussed if our Board should involve other Community Planning Board's from communities along the I-5 corridor to join in the opposition of freeway widening.
- Eduardo Savigliano will be reviewing correspondence to date and proposing to the Board a plan of action to continue this matter with Sandag.
