B. Torrey Pines Association: Peter Jensen; Short Presentation; Q&A -

- Peter Jensen and Adam Gevanthor presented to the Board on behalf of the Torrey Pines Association.
- Their goal is to open up the lines of communication between TPA and TPCPB.
- The presentation emphasized that projects within the community and around the Torrey Pines Reserve and Extension, should be looked at very closely, as they can greatly impact the ecosystem and view shed of the Reserve.

- Mrs. Hayes, along with audience members voiced concern about the increased amount of speeding motorists on Portofino Dr.
- Audience members requested that there be multiple stop signs added to Portofino Dr. at the cross streets of Calais, Mango, and Longboat to slow speeding motorists down.
- Troy Van Horst motioned that the Board request stops signs be added to Portofino Dr. at the cross streets of Calais, Mango, and Longboat, seconded by Dennis Ridz, and unanimously approved by the Board. In addition, the motion was amended to add crosswalks at each new stop sign.
