Jeff Burges asked for time from the Chair to object to Chair's decision to move meetings to in person without consulting Board.

C. MODIFICATIONS TO THE AGENDA: *Motion to Approve the Agenda – I have no minutes notes on a motion to approve the agenda*

D. ACTION TO APPROVE PAST MEETING MINUTES: July 2022 minutes were not submitted in time to meet Brown Act rules, thus will be voted upon at October meeting. Deborah Courier had comments that required modification. Jeff Burges submitted revised July 2022 meeting minutes on September 26th.

E. REPORT BY TREASURER: If a change in Balance – No Change

BRIEFING, INFORMATION, QUESTION & ANSWER (non-action)

Local resident – concerned about Changes approved for planning groups. No longer free appeals, now \$1,000 to file an appeal.

Council approved, but there will be a 2nd reading. Resident is very concerned.

CPC –**Brad** – City Council September 13th regarding Code amendment and Local Coastal program Chapter 8, article 6, Chapter 9, article 5 (10 minutes)

CPC – Brad – didn't go to the last meeting. Eduardo went to the last meeting but is not on the board any longer. Brad will continue to be on board and will continue to go to CPC. Need a 2nd person to attend if Brad can't go. Best to have 3 participants. Recruit alternatives for CPC. Providing two attendees receives a lot of respect.

Adam posed question to City Krissy – because we are in coastal zone, coastal act mandates community involvement in order to obtain permit. How does City handle LCP if no CPG. Krissy agreed to look into this.

SANDAG – Train Realignment – Dennis Ridz reports: Blue line alignment out, now only Red and Yellow alignment. SANDAD continues to want dedicated open space at Pointe Del Mar, including endangered plant species for the outlet of the three tunnels (two way tracks and escape tunnel) as well as Tunnel Fans. Fan System is 3 stories high. Diesel Fume exhaust is a concern. Fans placed in the mid span move air out to the North and South. These fans move fresh air into the tunnels as well.

Dedicated Open Space is not Reserved Open Space. Might be their opportunity to change that.

Ian raised question if anyone has looked at Dedicated Open Space from a legal standpoint. Answer no. Dennis said EIR will look at that.

Coastal Protection group of SANDAG – Dennis Ridz reports: Solana Beach has 700,000 cubic feet of sand for replenishment. Sand will clog up Los Penasquitos lagoon. 2016 sand at Solana Beach resulted in four closures of the lagoon.

Dee Rich reports: Dee met with Mike Hastings and the Mayor. Dee and Mike provided proof that sand creates closures, so we need money set aside for mitigation for the Lagoon. The Lagoon Committee only has one reopening budget per year. West Nile required spraying last time when closure occurred. Per Dennis, Joe LaCava is on that panel. Krissy believes Mike and Brian speak often and a briefing has likely occurred.

Dennis raised Board of Directors Size for discussion. The board discussed increasing board size from 13 to 16 people. 600-24 says you can't have a minimum less than 12. The Board discussed and voted unanimously to go to 16 board members. Board must seek City Attorney approval. By-Laws need to be amended.

Board discussed amending by-laws to allow in person meetings to occur outside jurisdiction. Board decided to shelve this subject until Hybrid/Zoom/In Person decision is made.

Board of Directors' Attendance Requirement for Electing new Board members. Our current By-Laws say attending 3 meetings is mandatory. Board discussed going to zero. By-Laws will need to be changed. Board agreed to wait and leave by laws as they are.

Board discussed Renters on the Board of Directors. City is not mandating renter involvement, but renters are encouraged.

Sorrento Valley Town Council member attended and Tina (BOD prospect) in attendance offices in Sorrento Valley. Board discussed getting more Sorrento Valley representation. Board discussed Web Site needing work to attract people. Public attendee Sean Tompkins provided contact information: Sean Tompkins sftompkins@gmail.com.

Board took no action on this issue.

• CPG passed – Joe LaCava sponsored. Joe fought for CPGs and softened changes. City providing tech and financial support.

- CIP Projects due October 7th
- Mercado Traffic light approved and funded, do we need to keep on CIP list still? It is on June 2022 list. Deb C. expressed concern about new board member being against.
- Add to agenda for October meeting on CIP list the list due October 7th will not include these. BOD decided we will go with June list for Oct 7th submittal
- Changing budget timing helps get more items into Mayor's budget.
- Bahama Cove repaying planned for end of September start with actual construction commencing end of October.
- Adam G. asked Krissy about Utility Undergrounding, per Eduardo's request. Krissy did not have information on that subject. Adam asked if Krissy could brief us on status next time.

Cole Reed reported as follows:

- Busy Bills month! 400 bills in next 10 days. Senator Atkins has five bills on her desk, three of which she authored or coauthored.
 - Climate Legislation coauthored establishes goal for 100% renewables by 2035 (1020)
 - San Diego River Conservancy expands jurisdiction to entire county of San Diego and recognizes indigenous species. (1027)
 - o Permit Sales Tax Exemption for non profit thrift stores on military bases. (1041)
